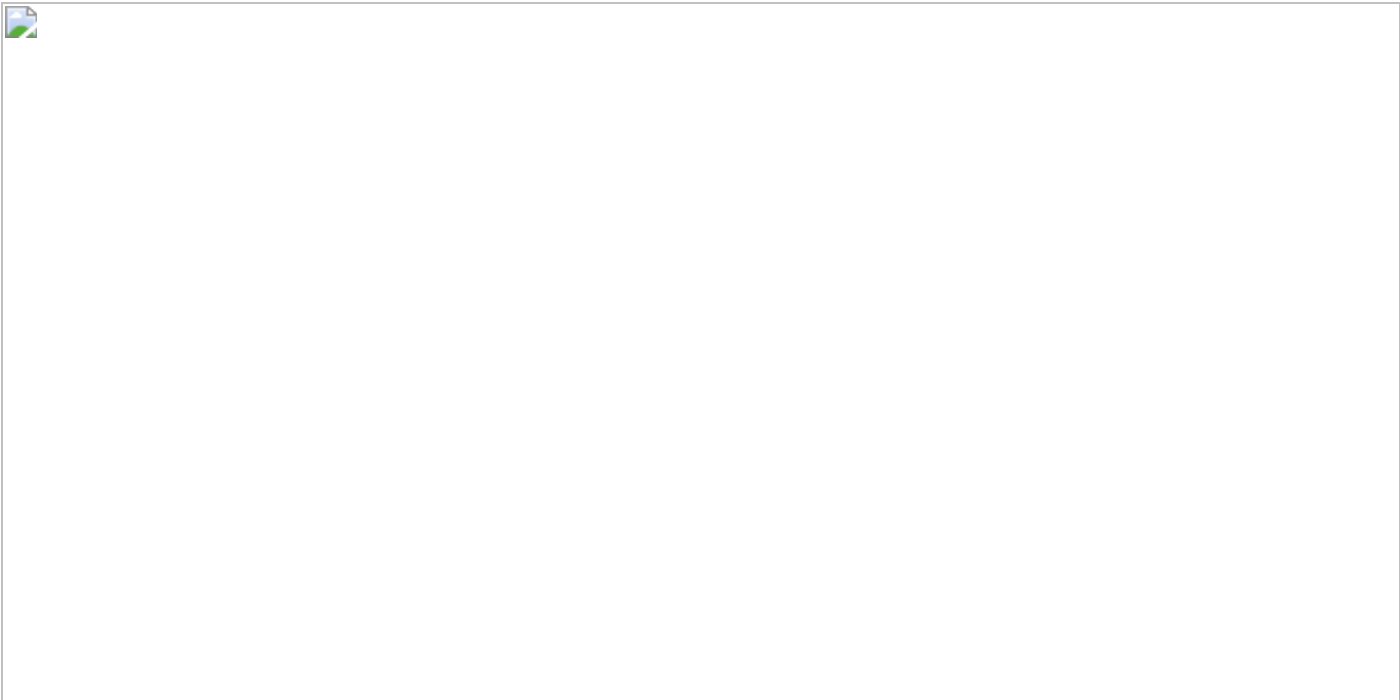
Median Sales Price | Price of the ""middle"" property sold -an equal number of sales were above and below this price.

Average Days on Market | Average days on market for all properties sold.

Sale Price as a Percentage of Original Price | Average sale price of property as percentage of final list price.

Average Days on Market | Average days on market for all properties sold.

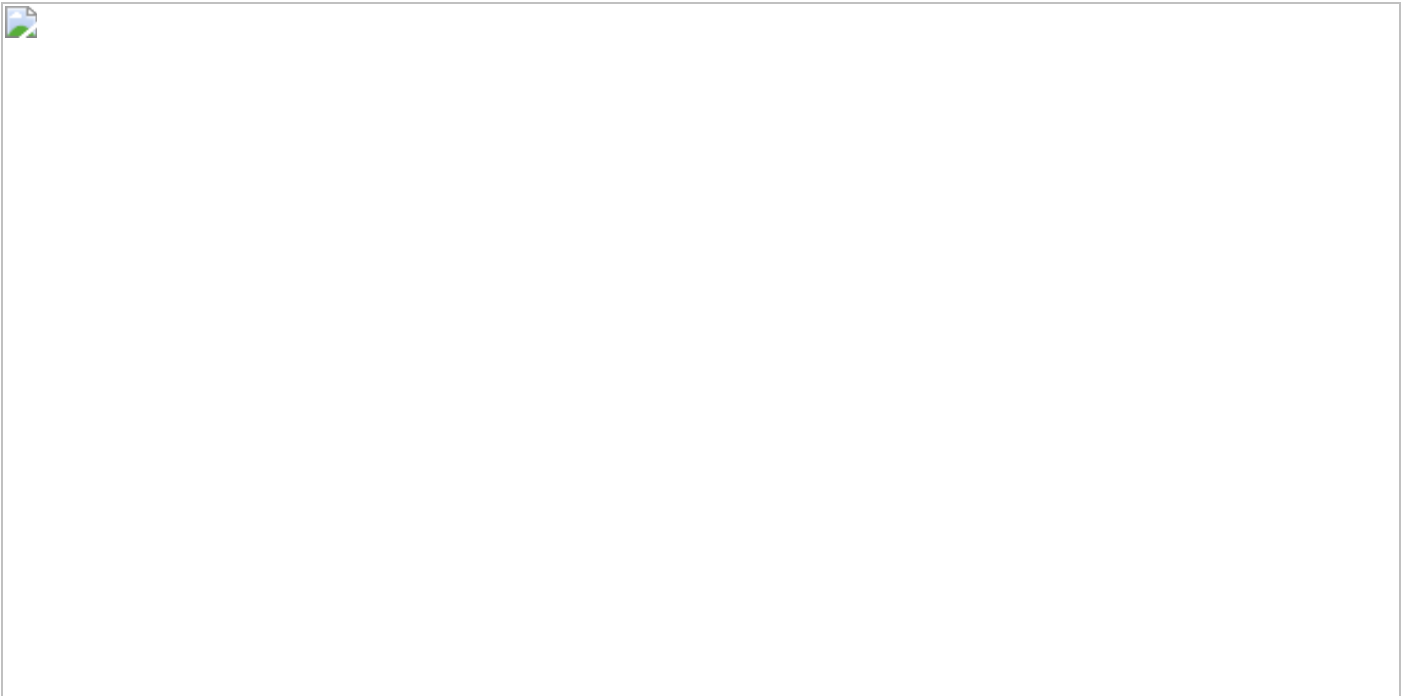


AVERAGE SALES PRICE AND NUMBER OF PROPERTIES FOR SALE
